This National Council for Teacher Education is a statutory body, that came into existence in pursuance of the National Council for Teacher Education Act, 1993 (No. 22 of 1993) on the 17<sup>th</sup> August, 1993, to achieve planned and coordinated development of the teacher education system throughout the country, the regulation and proper maintenance of Norms and Standards in the teacher education system and for matters connected therewith.

As part of one of the conditions of recognition, NCTE insists on the submission of a Performance Appraisal Report annually which includes an annual statement of activities duly audited by a Chartered Accountant. Similarly, as section 17(3) & (4) of the NCTE Act, 1993, the following is mandatory:

- examine and review periodically the implementation of the norms, guidelines and standards laid down by the Council, and to suitable advise the recognised institutions;
- evolve suitable performance appraisal system, norms and mechanism for referring accountability on recognised institutions;

In view of the above, the General Body of the Council in its 6<sup>th</sup> meeting held on 5<sup>th</sup> August, 2024 decided that the PAR appraisal Reports (PAR) for the Academic Sessions 2021-22 & 2022-23 are mandatorily required to be submitted online by all the entities - Teacher Education Institutions (TEI) on the NCTE portal (<https://ncte.gov.in/Website/PAR.aspx>) and it should be submitted for the academic sessions 2021-22 & 2022-23 through online mode only. Necessary payment be made as given in the General Instructions.

Timeline to submit the online PAR shall be from 09 September, 2024 to 15 November, 2024 (11:59 pm).
